- b) The candidates should report along with **Original Certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.

- a) Candidates are advised to check the website of the DGHS (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: [www.mcc.nic.in](http://www.mcc.nic.in) and College website: [www.avmc.edu.in](http://www.avmc.edu.in) from time to time.
- b) Allotment letter given by the DGHS for admission is subject to fulfillment of all eligibility criteria prescribed by the MCI and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
