VMRF-DU GUIDELINES / POLICY FOR AWARD OF INCENTIVES WITH RESPECT TO RESEARCH

PUBLICATIONS

A. Research Publications in Journals, National/International Conferences and Workshops

1. The University shall lay down the conditions, for the publication of the research papers in journals/conferences by the faculty which is mandatory, to promote the research activities in the University and its constituent colleges.
2. The University encourages all its faculty members, to publish their Research papers in the SCOPUS indexed /Web of Science or refereed National/International journals. The University awards cash incentives for these research publications. A Research Committee (RC) constituted by the University for each Constituent college is authorized to recommend these incentives after ensuring the following conditions
 - a. The paper should have been published in the SCOPUS Indexed/Web of Science or refereed Journals having the impact factor prescribed by the University from time to time.
 - b. The paper must be published in the name of the faculty as a corresponding author and should be in affiliation with VMRF-DU
 - c. Any other conditions which the research committee deems fit.
3. The research committee shall meet twice in a year for awarding the cash incentives, if required, during July-August and January-February
4. There shall be no ceiling limit on the number of publications an individual faculty can publish
5. The faculty members are encouraged to submit the papers in the journals with high impact factors.
6. A cash incentive of Rs 2000/- for each paper published in the journals as prescribed above
7. Financial Assistance for Faculty presenting the paper in National/International Conferences

8. Conditions for Sanction of Financial Assistance said in the item 6 above

- a. Faculty member should have made oral Presentation of his paper.
- b. Faculty should be a Full Time employee
- c. If there are authors more than one for a paper, only one author will be eligible for financial assistance
- d. The Financial assistance for participation in the National/International conference is funded, subject to review of the RC by screening the papers prepared and presented by the faculty. The RC will also verifying the credibility of the conference.

B. Book Publications

1. The University encourages its Faculty members to publish books in their relevant academic fields, subject to the condition that the book has ISBN number with Indexing
2. The faculty member who publishes a book having the ISBN number, Rs 5000/- per book as cash incentive shall be awarded
3. The Research Committee shall recommend to the institution for awarding such cash incentives

C. Patents

1. The University encourages its Faculty members to get the patents for their research work
2. The faculty shall receive Rs. 10,000 for a filed and published patent as incentive.
3. The publication cost of the patent will be Borne by the Constituent colleges of University
