- b) The candidates should report along with **Original Certificates and Demand Draft or UTR Number for Electronic Fund Transfer through RTGS / NEFT** for the prescribed tuition fee and other fee as specified herein below.
- c) i) Candidates without original certificates / documents **shall not** be allowed to take admission in the allotted Medical College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Medical College.

- d) Every student shall pay the tuition fee and other fee as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fee are not permitted.
- f) No extension of time either for payment of fee or submission of original certificates will be entertained under any circumstances.
- g) At the time of admission, candidates should sign declaration / undertakings declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC / NMC and observe the good conduct and behavior and that they are bound by the University rules on payment of fees / refund of fees.

- a) Candidates are advised to check the website of the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi **website: www.mcc.nic.in** and **College website: www.avmc.edu.in** from time to time.
- b) **Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the NMC and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by **the MCC of DGHS**. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
